



**Notice of Race  
2010 Fall Series  
2011 Hangover Regatta**

**Classes:**

This is a PHRF regatta by invitation of the Augusta Sailing Club. Boats must have a current ASC PHRF Certificate and comply with the ASC PHRF rules. Fleets will be divided into Spinnaker and Non-Spinnaker.

**Scoring:**

The Fall Series includes all races held as the 2010 Fall Series including the Hangover Regatta on January 1, 2011. Scoring of each race will be based on corrected times. Corrected times will be calculated with the "Time-on-Time" method using PHRF ratings.

All races on each race day of the Fall Series will be scored as a daily regatta using the low point system. Boats scored DNC for any daily regatta will be awarded points based on the rule for an extended race series provided in the Racing Rules of Sailing. Fall Series scoring shall include all of the daily regatta scores excluding each boat's two (2) worst daily scores. Trophies will be awarded in each fleet.

The 2011 Hangover Regatta is a separate event and will be scored as a 1-day regatta using the low point system and standard regatta scoring as provided in the Racing Rules of Sailing. Trophies will be awarded in each fleet.

One race on each of three (3) separate days will constitute a regatta for the Fall Series. One race will constitute a regatta for the Hangover Regatta.

**Fees:**

Entry fee for the Fall series is \$40 per boat, and includes the 2011 Hangover Regatta. Entry fee for the Hangover Regatta only is \$25. Members of US Sailing will be given a \$5 discount on either fee.

**Registration:**

Registration will be allowed at any time up until the start of a race on any race day. A completed registration form and entry fee shall be submitted as part of the registration. Payment is required at the time of registration, by cash or check, or by signature on the registration form authorizing the Club to charge the fee on the member's quarterly bill.

**Rules:**

The regatta is governed by the USSA RACING RULES OF SAILING, applicable class rules, Augusta Sailing Club PHRF rules, and Sailing Instructions (available at registration).

**Schedule:**

A Skippers Meeting will be held at 10:00 AM on the first Race day, and on the day of the Hangover Regatta. The starting sequence will begin at noon each day.

December 18, 2010

January 1, 2011 – both Hangover Regatta and final day of Fall Series
