Classes:

This is a PHRF regatta by invitation of the Augusta Sailing Club. Boats must have a current ASC PHRF Certificate and comply with the ASC PHRF rules. Fleets will be divided into Spinnaker and Non-Spinnaker.

Scoring:

The Winter Series includes all races held as the 2011 PHRF Winter Series including the Saturday Races of the Mid-Winter Cup Regatta on February 26-27, 2011. Scoring of each race will be based on corrected times. Corrected times will be calculated with the "Time-on-Time" method using PHRF ratings.

All races on each race day of the Winter Series will be scored as a daily regatta using the low point system. Boats scored DNC for any daily regatta will be awarded points based on the rule for an extended race series provided in the Racing Rules of Sailing. Winter Series scoring shall include all of the daily regatta scores excluding each boat's two (2) worst daily scores. Trophies will be awarded in each fleet.

The 2011 Mid-Winter Cup Regatta is a separate event and will be scored as a 2-day regatta using the low point system and standard regatta scoring as provided in the Racing Rules of Sailing. Trophies will be awarded in each fleet.

One race on each of three (3) separate days will constitute a regatta for the Winter Series. One race will constitute a regatta for the Mid-Winter Cup Regatta.

Fees:

Entry fee for the Winter series is \$50 per boat, and includes the 2011 Mid-Winter Cup Regatta registration. Entry fee for the Mid-Winter Cup Regatta only is \$35. Members of US Sailing will be given a \$5 discount on either fee.

Registration:

Registration will be allowed at any time up until the start of a race on any race day. A completed registration form and entry fee shall be submitted as part of the registration. Payment is required at the time of registration, by cash or check, or by signature on the registration form authorizing the Club to charge the fee on the member's quarterly bill.

Rules:

The regatta is governed by the USSA RACING RULES OF SAILING, applicable class rules, Augusta Sailing Club PHRF rules, and Sailing Instructions (available at registration).

Schedule:

A Skippers Meeting will be held at 10:00 AM on the first race day of the Winter Series, and on the first day of the Mid-Winter Cup Regatta. The starting sequence will begin at noon on the Saturday race days and at 11:00 AM on the Sunday race day of the Mid-Winter Cup Regatta.
